## GENERAL INFORMATION

ENCOURAGE® CLASSIC is a 2-1-2 fertilizer with a wetting agent to ensure complete foliar coverage. It also contains humic acid that may aid in the uptake of micro-nutrients. It can be used on agricultural crops, ornamental plants and commercial turf to stimulate plant growth. CLASSIC can be used as a one-time application or as part of a season-long fertility program.

## DIRECTIONS FOR USE

Prior to use, read all the directions on this label and on the label of the tank mix partners being used with this product. Thoroughly clean all mixing and spray application equipment prior to and following each use. Unless directed otherwise by mixing instructions on the label of product to be tank mixed with CLASSIC, add desired amount of water to the tank and begin agitation. Add CLASSIC and continue agitation. If desired, add liquid fertilizer or other tank mix partners. CLASSIC can be applied as a foliar spray by air, ground or chemigation. CLASSIC can be tank mixed with most pesticides and nutrients.

## MIXING DIRECTIONS (COMMERCIAL USE ONLY)

### AGRICULTURE:

Spray with sufficient solution to wet foliage, but not to the point of runoff. (Row crops: 10 fl. oz. to 2 quarts per acre) Apply 2–3 times per growing season. Plants need to be just past the seedling stage and true leaves should be present - about 25% coverage of the ground before the first application. Second application is usually just before flowering, or just before the onset of the reproductive stage of the crop. The third application would be early in the grain fill or fruit/vegetable sizing stage. (Tree and Vine crops: 1–2 quarts per acre) Apply 2–3 times per growing season when leaves are present.

### NURSERY, GREENHOUSE, ORNAMENTAL AND LANDSCAPE:

(Succulent plants: Mix 64 fl.oz. in 100 gallons water) (Woody plants: Mix 96 fl. oz. in 100 gallons water) Spray with sufficient solution to wet foliage, but not to the point of runoff. Apply every 14–21 days or as needed. Plants need to be just past the seedling stage - about 25% coverage of the ground before the first application. Second application is usually just before flowering, or just before the onset of the reproductive stage of the plant. The third application would be early in the seed fill or fruit/vegetable sizing stage.

### GOLF COURSE SUPERINTENDENTS, LANDSCAPERS, GROWERS AND NURSERY OPERATORS\*:

SOD, FAIRWAYS, LAWNS AND GREENS: Mix 3 fl. oz. per 1 gallon of water. Apply 1 gallon solution per 1000 square feet (or 40 gallons solution per acre) every 10–14 days or as needed.

\* In Virginia, use only on 1. newly established turf areas from sod or seed during the first growing season; 2. turf areas being repaired or renovated; 3. turf areas where soil tests performed within the past 3 years indicate a nutrient deficiency. \* DO NOT apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden, and sweep any product that lands on the driveway, sidewalk, or street, back onto your lawn/garden.

## APPLICATION PRECAUTIONS

DO NOT mix with or add other surfactants. Applicator should spray and evaluate response for 48 hours prior to widespread usage. May cause staining on handler's apparel and hard surfaces. Application of certain nutrients during high temperatures may result in staining or cosmetic injury of fruit or rind. Test all new tank mixes before widespread use. Do not apply directly to seed. To ensure thorough mixing, it is suggested that you recirculate mini tanks and bulk tanks or shake containers before using. Do not mix CLASSIC with undiluted tank mix partners until you have "jar tested" in a separate container using the proportionate amount of CLASSIC to make sure the products are compatible. Agitate and let stand 10 minutes. Settling that does not disperse indicates an incompatible mixture. Do not use on crops or plants that are sensitive to humic acid or surfactants.

## STORAGE AND DISPOSAL

**STORAGE:** Keep away from open flames, hot surfaces and sources of ignition. Store in a cool, dry, well-ventilated place out of direct sunlight. Store locked up. Store in original tightly closed container away from children, animals, foods, feeds and seeds. **PRODUCT AND CONTAINER DISPOSAL:** Do not allow this material to drain into sewers/water supplies. Empty containers or liners may retain some product residues. Triple rinse (or equivalent) during mixing and loading. Dispose of contents in accordance with local/regional/national/international regulations.
